1. I understand that GCES's unique Experiential Activity Program and hands-on Science, Technology, Engineering, Artistic Creativity & Mathematics (STEAM) makerspace program are supported in part by student fees. I further understand that these fees are necessary and cannot be waived. I also understand that these fees are fixed and predictable and I agree to pay our fees in a timely fashion.	Initial Here 1
2. I understand that GCES relies on its families to provide a consistent, predictable, weekly	
volunteer contribution to the school. I understand that this commitment cannot be waived regardless of family or work circumstances. I further understand that my child's enrollment is contingent upon my satisfaction of this volunteer commitment. I also understand it is my responsibility to contact the school's administration to establish a fixed volunteer role. 4. I understand that GCES has a commitment to protect instructional time; therefore I will allow my child to attend the entire school day and, in some cases, the mandated extended	Initial Here 4
school day, without interruption. If I am contacted by the school due to any missing or incomplete work or if my child needs remediation, additional instruction, or restitution. I will ensure that he/she participate in the extended school day for as many days as deemed

interrupt the extended school day classes. I agree that, barring extreme emergency situations, to transport my child only at the designated dismissal times.

6. I understand that the GCES Experiential Activity Program (EAP) and its associated trips are a required, graded, mandatory part of the school's instructional program. I will ensure that my child participates faithfully in all EAP activities OR the designated alternate activity when a documented physical limitation exists. Missing EAP days are permitted only through illness and must be documented through a licensed physician note . I also understand and agree that make-up for the EAP program may only occur through Extended School Day (ESD) sessions and that multiple ESD sessions WILL be required to complete the alternate EAP activities. I further understand and agree that the EAP program day may be modified as a result of a failing grade in any course. This may result in my child staying back from the activity and participating in academic remediation in addition to the EAP	Initial Here 6
alternate activity sessions at the discretion of the school's administration.	
I understand and agree that the GCES "School Money" system is designed to foster sponsible behavior and reward self-control and is a required aspect of enrollment. I further derstand that my child must maintain a positive balance in order to participate in the hool day. While remedies exist to correct negative balances, these remedies should be diciously used as a last resort and should not become a pattern. Patterns of extended lunteerism to correct negative balances will result in administrative and guidance referrals the the associated parent conferences. I also understand that my child will be suspended om participation in the regular school day and/or the Experiential Activity Program (EAP) ould negative balances be sustained (carried) from one week to the next. I also understand and agree that if disruptive behavior on the part of my child becomes a pattern, then a step-based disciplinary approach will be implemented that may result in multiple days of suspension and possible recommendation for removal from GCES and placement in his/her zoned school. I understand that the school has a published, conservative dress-code policy with a standard elementary school uniform that is strictly enforced and agree to ensure that my child's dress, hair styles, hair color, and attire conform to this conservative dress code. I further understand and agree that my child will be placed in an alternative educational environment (i.e. school office) during the period of time that they are out of compliance with the school's dress code. 12. I understand that state-mandated testing exists in this state and that charter schools are required by the Florida Statutes to ensure that all students are tested. I further understand that the success of the school's educational program and the school's grade are based upon the collective results of this test, I therefore agree, as a condition of my child's continued attendance at this charter school, to require my child to FULLY PARTICIPATE in the state mandated testing and to encourage them to put forth their best effort. I understand that should my child not participate in these ESD intensive classes, their EAP day may be withheld so they may complete the Day may be withheld in order to complete the lessons missed during these intensive classes and an alternative EAP assignment will be provided for the EAP grade. 16. I understand that the charter elementary school <u>does not require nor desire</u> the students to have cell phones or any electronic device while at school. I further understand that my child <u>may</u> bring a cell phone to school ONLY if used off-campus. I further understand that GCES does NOT allow cell phone usage on campus. I agree to direct my child to follow all school rules regarding the use of cell phones and I also agree to discuss the school cell phone rules with my child prior to allowing them to bring a cell phone (or other electronic device) to school, I also agree to accept the consequences that may result from my child's misuse of these devices.

A summary of the rules appears below, but this is not a comprehensive list: CPD = Cell Phone / Electronic Device

- CPDs must be turned off when on campus
- CPDs must never be used in the classroom
- CPDs may never be used to record, photograph, video/audio record or display images
- CPDs may never be used during Experiential Activity Program or on the bus
- CPDs may never be used to view inappropriate media content
- CPDs may never be used to record "selfies" or social media interactive photos
- CPDs may never be used to embarrass a student or staff member
- CPDs may never be used to record another student or take their photograph
- CPDs may never be used to transmit obscene or offensive language
- CPDs may never be used to annoy, threaten, intimidate, offend, or harass another student.
- CPDs must be invisible while on the school campus.
- CPDs will be confiscated by school employees and returned ONLY TO THE PARENT / GUARDIAN when a CPD rule violation occurs.

17. I agree to direct my child to attend the Extended School Day clinics and provide transportation as necessary when their grade on ANY progress report drops below a "C" (70%) in ANY graded class. I understand that all classroom teachers will allow my child to "repair" grades that are below a 70% through the additional instruction and remediation that occurs through the extended school day clinics. I understand that it is the responsibility of me and my child to ensure these clinic meetings occur. I understand that "grade repair" is only available for a limited period of time (three weeks) following the assignment's due date.
